

KINGDOM SECURITIES

Equities Market

- Weekly market activity remained stable for a second week in a row with the NSE 20 easing by 0.2% from 1,863.25 to 1,858.87 points. NSE 25 and the NASI index remained flat forcing the market cap to remain flat.
- Interest in Safaricom (Kes. 39.5, + 0.3%) saw the volumes spike 14.9% from 81.04Mn to Kes. 93.08Mn shares. This further pushed the market value traded 4.2% up to Kes. 3.18Bn from Kes. 3.05Bn in the previous week.
- Foreign activity improved 1,310bps from 44.4% to 57.5% with a net outflow of Kes 1,617.45Mn. Safaricom retained a strong foreign activity on both sales and buys. Its foreign buys stood at Kes. 804.66Mn in comparison to Kes. 834.01Mn in the week before. Its foreign sales improved 93.5% to Kes. 2,421.93Mn from Kes. 824.16Mn. EABL and Equity followed on foreign buys at Kes. 103.38Mn and Kes. 92.97Mn respectively.
- Uchumi was stop gainer amassing 13.0% from Kes. 0.23 to Kes.
 O.26 having moved 239,400 shares. Nation Media and Nairobi Business Ventures followed at 10.5% and 9.0% from Kes. 15.05 to Kes. 16.65 and from Kes. 4.90 to Kes. 5.34 for NMG and NBV respectively.
- Unga group lost the most at 11.9% to Kes. 28.00, after recording a 44.2% decline in PBT for FY 2020 to Kes. 122.54Mn from Kes. 219.42Mn in FY 2019 The volumes traded for Unga Group stood at 4,700. HFCK and Liberty followed with losses of 9.5% and 7.3% from Kes. 4.00 to Kes. 3.62 and from Kes. 7.98 to Kes. 7.40 respectively.

Following the award of a telecommunication license to Safaricom by the Federal Republic of Ethiopia, we expect a continued price surge on the counter whose valuation we shall publish in due course.


Bonds Market

- The bonds market moved Kes. 21.63Bn, a 5.5% improvement from Kes. 20.49Bn in the previous week. Bonds activity jumped 37.7% up from 422 deals to 581 deals.
- The infrastructure bonds remained dominant with the IFB1/2021/18 accounting for 42.5% of the total market deals and 29.5% of the total market value.

Yield Curve

The short end and long end of the yield curve remained stable despite increased activity on both sides. The middle year gap widened as yields continued on an upward trend.




Interbank

Liquidity remained fairy adequate with the interbank closing at 2.65bps higher from 4.97% to 5.00%. Average interbank jumped to 4.88% from 4.07% attributed to the tight liquidity at mid-week.

The average volumes traded eased 38.7% from Kes. 12.38Bn to Kes. 7.59Bn. Banks' excess liquidity improved to Kes. 19.10Bn from Kes. 9.60Bn in the previous week.

We expect liquidity to improve in the coming week with the expected T-bill maturities of Kes. 24.33Bn and coupon payments of Kes. 10.28Bn.




T-Bills

- T-bill activity improved W/W with all the three papers being oversubscribed >100%. The total amount subscribed improved by 46.3% from Kes. 26.58Bn to Kes. 38.88Bn while that accepted went up 9.4% from Kes. 20.45Bn to Kes. 22.37Bn.
- Yields on the papers went down 0.1bps, 4.2bps and 10.6bps for the 91, 182 and 364-dy papers from 7.156%, 7.995% and 9.390% to 7.155%, 7.953% and 9.280% respectively.

Currency

- The Kenya shilling continued weakening W/W against major currencies easing 1.1%, 1.1%, 1.7% and 1.0% from Kes. 107.02, Kes. 151.21, Kes. 129.75 and Kes. 98.38 to Kes. 108.23, Kes. 152.91, Kes. 132.01 and Kes. 99.32 against the dollar, pound, Euro and Japanese yen respectively.
- Foreign reserves remined adequate at USD. 7,546Mn, a 0.6% drop from that of USD. 7,594.10Mn in the week before.
- The U.S. dollar gained on Friday 21st May 24, 2021 against a number of major currencies boosted by encouraging U.S. manufacturing data. This was after the factory activity gathered speed amidst a strong domestic demand.
- Elsewhere, the loosening of covid-19 restrictions improved business activity in Europe which still had little effect on Euro.
