

Equities Market Summary

- Overall market activity inched up as all the indices fell on foreign exits in major counters on the looming persistent rising inflation both locally and globally plus the upcoming holiday season.
- NSE 20 fell 2.2% to 1,992.92 points on losses experienced in Safaricom (Kes. 41.65, -3.6%), Equity (Kes. 49.35, -2.3%) and KCB (Kes. 46.10, -1.4%) as majority of their counter parts shed at least 1.8% (see pricelist at the end of the report). Both NSE 25 and NASI indices shed 3.0% each.
- Foreign activity stood at 56.6% as net outflows almost doubled to Kes. 801.89Mn from that of Kes. 419.54 Mn in the week before. Overall foreign sales stood at 70.6% as foreign buys receded to 42.7%. Increased foreign outflux was witnessed in Equity, KCB and EABL and thus the losses witnessed on their prices.
- In the course of the week EABL issued a 5-year MTN of Kes. 11.00Bn for the purposes of increasing its working capital and repaying /refinancing some of its short-term borrowing obligations. The offer began on 6th October and will close on 21st October 2021.

Bonds Market

- Tight liquidity saw the bonds market activity drop 27.2% to 419 deals pushing the value traded 45.5% down to Kes. 12.57Bn from that of Kes. 23.05Bn in the week before.
- In the primary market, a total of Kes. 55.48Bn was received representing an undersubscription of 92.5% as CBK accepted Kes. 52.05Bn.




The Derivatives turned active trading 146 contracts valued at Kes. 5.47Mn compared to 99 contacts and Kes. 3.65Mn in the week before.

T-Bills

The T-bill auction saw an undersubscription on all the papers of total Kes. 9.82Bn at >99% acceptance. Yields remained on an upward trend with the 364-day paper gaining the most at 7.9bps w/w as per our earlier prediction.

With the upcoming T-bill redemptions of Kes. 27.82Bn and coupon payments of Kes. 15.90Bn, we expect liquidity to improve with an interbank rate of <6.0% and a T-bills subscription of c.t. 100% in the coming week.





Currency

The shilling remained under pressure w/w easing 0.2% 1.0% and 0.3% against the dollar, pound and the Yen respectively while remaining strong against the Euro with a 0.4% gain.

Faster rise on imports at 22.9% compared to that of exports at 11.5% (as at end of August) amid the rising international oil prices and rising inflation, continues adding pressure on the foreign reserves which eased 0.8% w/w to close the week at USD. 9,365Mn. Foreign remittance stood at USD. 312.93Mn by close of August 2021, a 7.1% drop from that of USD. 336.71Mn in July.
