

### **Equities Market Summary**

- The market activity rejuvenated on return of foreigners beckoned by curfew liftings which had lasted for nearly 2-years. Volumes traded spiked 33.9% to 73.21Mn shares which pushed the market value 53.2% up w/w to Kes. 3,210.13Mn.
- The market indices remained relatively stable with the NASI index easing 0.2% on pressure from the NSE counters which shed 0.5% to 1960.75 points partly on losses from Safaricom (Kes. 42.95, -0.4%) KCB (Kes. 44.20, -2.0%) and Co-op (Kes. 12.75, -1.9%). NSE 25 index stabilized at 3,865.42 points.
- Foreign activity stood strong at 67.4% with a net foreign inflow of Kes. 36.99Mn from negative outflows witnessed in the last four weeks in a row. The about-turn was partly attributed to the curfew lifting and ease of movement, especially night travels.
- Safaricom remained the favorite counter for foreigners at 90.9% of its buys followed by EABL (Kes. 169.25, 2.7%) at 79.0%. EABL stands to gain in the coming week on ease of night movement restrictions.
- Sasin Tea emerged the top gainer at 10.2% from Kes. 19.05 to Kes. 21.00 on anticipated better results for the year ended 30<sup>th</sup> September 2021.
- Eveready lost the most 17.4% from Kes. 1.09 to Kes. 0.90 after moving 59,000 shares followed by NBV which dropped 14.8% from Kes. 5.94 to Kes. 5.06.

### **Bonds Market**


The secondary market activity improved by 22.9% which saw the value traded rise 48.1% to Kes. 15.31Bn. The IFB1/2021/21 was the most sought paper moving 27.4% of the market value.

### **Derivatives market**

A total of 41 contracts were traded values at Kes. 1.47Mn which represented 43.8% reduction on its market activity.


The yield curve experienced slight shifts on both ends with short end shifting upwards on improved yields as the long end shifted downwards having been affected by low liquidity.

• Bank excess liquidity improved 33.0% as the week progressed to cross at Kes. 13.30Bn, a 33.0% improvement from that of Kes. 10.00Bn in the week before.



### **T-Bills**

- T-bill undersubscriptions remained present with a total of Kes. 17.82Bn at 89.0% acceptance with the 182-day paper's acceptance being the lowest at 70.6% on low rates.
- Yields on the 364 and 91-day papers remained on an up-trend at 13.0bps and 6.8bps respectively.




In the coming week, we expect liquidity to remain low with an interbank rate ranging between 4.85% and 5.15% on low coupon payments of Kes. 4.17Bn and T-bill maturities of Kes. 20.22Bn which will be partly re-invested in the upcoming T-bill auction.



#### Currency

- The Kenya shilling weakened w/w hitting the Kes. 111.06 mark against the dollar, a further 0.2% loss from that of Kes. 110.07 last week. The shilling also shed 0.9%, 0.5% and 0.1% w/w against the Pound, Euro and the Yen to Kes. 153.32, Kes. 129.32 and Kes. 97.37 respectively.
- Dollar reserves dropped 0.4% further to cross the week at USD. 9,228Mn on low exports and high imports as the foreign remittances fell 1.0% M/M to USD. 309.80Mn in September.
- Elsewhere, the dollar remained unstable against other major currencies on asset purchases reduction and the stabilization of low interest rates declared by the Fed amid high inflation and low employment statistics.
