

Equities Market

- Equities activity slowed down despite the better earnings witnessed in some of the banking stocks. Volumes traded eased 30.1% to 70.85Mn shares as prices on several counters remained volatile on yet another heavy foreign exits plus the approaching holiday season.
- All the indices fell at an average of 1.5% being led by the All index share at 1.8% to 168.43 points, recording its lowest level since late May 2021. NSE 20 index shed 1.4% on shocks from top liquid counters, Safaricom (Kes. 39.25, -2.4%), Equity (Kes. 52.00, -1.0%) and EABL (Kes. 157.00, -3.2%) as only 5 of its constituents saw upticks. See pricelist at the last page.
- Interim dividend declaration on KCB Group and Stanchart saw their volume surge as the rest of the banks was little to negative improvements on their volumes traded.
- Stanchart recorded a 35.7% Y/Y increase on profits before tax (PBT) from Kes.6.56Bn to Kes. 8.90Bn in Q3-2021. Find our earnings update here.
- Co-op Bank posted a 19.9% growth in PBT from Kes. 13.75Bn in Q3-2020 to Kes. 16.48Bn in Q3-2021. Find our earnings update here.
- Eagards plc recorded an 85.3% drop in PBT for its half year results ending 30th September 2021.
- HFCK emerged the week's top gainer on market reaction to Equity Group's interest in acquiring a major stake on the counter. This was after Britam's plan to sell its 48.2% shareholding in the HF group.
- NBV suffered another set-back after recording a 28.4% W/W loss from Kes. 5.32 to Kes. 3.81. This was after the shareholder's approval of 100% share acquisitions in Delta Automobile, Deltra Cement Ltd, Air Direct Connect Ltd and Aviation Management Solutions Ltd which happened on 18th October. The acquisition's total value was Kes. 3.00Bn.
- Stanchart is set to gain from the expected high foreign entry on its addition to the MSCI Frontier Markets Small Cap Indexes. BAT Kenya was removed from the same as per the November MSI index report released last week.



Bonds Market

A total of 466 deals were transacted values at Kes. 10.60Bn, a 10.6% and 40.9% drop from the previous week's performance. This was attributed to low liquidity levels in the market.

Derivatives Market

A 37.3% drop in the contracts traded was witnessed whose value stood at 3.93Mn compared to that of 142 contracts of Kes. 5.77Mn witnessed in the week before.


Yield Curve

Tightly liquidity witnessed in the week saw the yield curve remain relatively stable on the long-end as the short-end shifted upwards on the effect of November 5-year primary paper, which entered the secondary market in the week

Interbank

- The interbank rate edged higher in the week closing at an average of 5.20% on low liquidity as per to our earlier prediction. Average liquidity demand rose 11.3% from Kes. 9.86Bn to Kes. 10.97Bn.
- However, by the close of the week, bank excess liquidity edged 73.8% higher to Kes. 18.60Bn benefitting from accumulations for Excise duty, with-holding, VAT and Rental tax which happened on Friday.



In the coming week we expect the interbank rate to drop to a range of 4.50% to 4.75% on T-Bill maturities of Kes. 31.17Bn and bonds redemptions plus coupon payments of Kes. 15.67Bn which we expect to improve liquidity levels the market.

T-Bills

- Subscriptions improved in the week receiving a total of Kes. 26.07Bn while accepting Kes, 22.35Bn with aggressive bidding from all the papers. The 91-day paper was the most subscribed at 209.9% on a tactical shift for funds conservation.
- Rates continued an upward movement with the 364-day paper still rising faster compared to the rest.
- We expect heavy subscriptions in the coming auction with high acceptance on high government appetite for funds.



Currency Performance

- The Kenya shilling remained on the losing end passing Kes. 112 mark at Kes. 112.18 against the dollar on the Euro bond coupon payments of USD. 75.90Mn for November. This was the forex reserves drop 2.4% from USD. 9,094Mn to USD. 8,873Mn as at the close of the week.
- We expect the shilling to remain under pressure for the rest of the year on high imports especially on oil import. Diaspora remittances and tea bonus is expected to give reprieve as the festive season nears.
- Inflation to remain contained on harvest season in the Western parts of Kenya and on the low base for the consumer price index for November.
