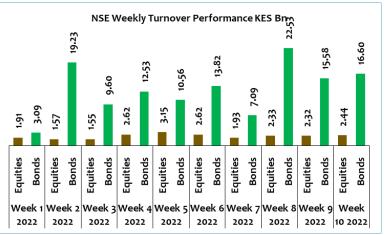

Equities

- Market continued with a downward tumble with the NSE 20 share index shedding a further 33.32 points to close at 1,864.58 points driven by losses in Safaricom (KES 35.50, -5.3%), EABL (KES 153.00, -2.4%), KCB Group (KES 44.70, -1.4%), Equity Group (KES 51.25, -1.0% and Co-op Bank (KES 12.86, -0.8%).
- Mid-cap companies dipped spilling the effect on the NSE 25 share index which dipped 2.4% to 3,613.10 points.
 Market value shrunk by 3.4% to KES 2,477.15Bn.
- Low interest in Safcom (35.50, -5.3%) pushed volumes traded down by 14.0% while interest in small cap counters aided push value traded up by 1.2% to KES 2.44Bn from KES 2.41Bn seen the previous week.
- Foreign activity improved to 67.8% from 60.3% with net exits of KES 0.43Bn which were 25.0% higher compared to KES 0.34Bn the week before.
- Attraction on bonus share of 1:1 and a per share dividend of KES 3.20 continues interest investors in Car and General as the counter closed the week as top gainer amassing 17.2% to end the week at KES 61.25, from KES 52.25. Exits in Trans-Century and East African Portland Cement left the counters as top losers shedding 18.5% and 11.3% to end the week KES 1.01 and KES 6.30 from KES 1.24 and KES 7.10 respectively.

Bonds Market

Secondary bonds market value traded increased by 8.4% to KES 16.89Bn from KES 15.58Bn despite number of deals declining by 11.2%. the value represented 0.5% of total government bond issued.

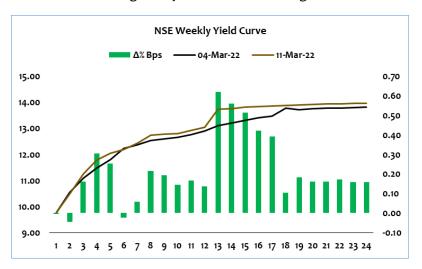

Yield Curve

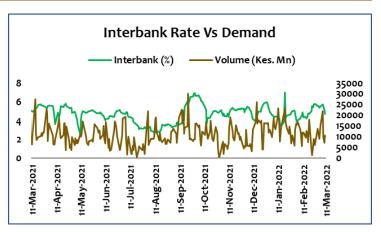

Money Market

Interbank

- Reduced demand for liquidity pulled the interbank rate 83.0bps down from 5.51% to 4.68%. Average interbank dropped 25.0bps from 5.51% to 5.26%.
- Demand for liquidity closed the week at KES 10.40Bn from that of KES 15.24Bn the week before. Average weekly liquidity demand closed at an average of KES 12.29Bn, a 2.1% up from that of KES 12.04Bn.
- Bank excess liquidity remained stable at KES 16.90Bn, a 0.6% uptick from that of KES 16.80Bn the week before.



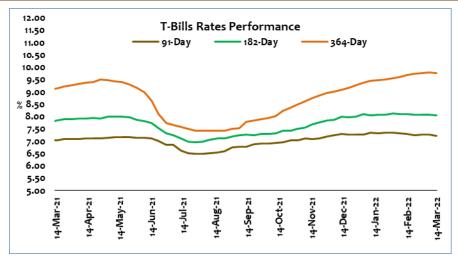

Treasury Bills

- Over subscriptions remained present at 102.1% of KES 24.50Bn aided by 133.9% and 132.4% subscriptions on the 364 and the 91-day papers with KES 13.39Bn and KES 5.30Bn respectively as investor preference remained present on these papers.
- Yields on the 364-day paper slid 5.9bps to 9.771% on signs of an about-turn after recording a 24-month high of 9.774% in the first week of March 2022. Yields on the 91 and 182-day paper remained on the declining mood as liquidity remained relatively stable.

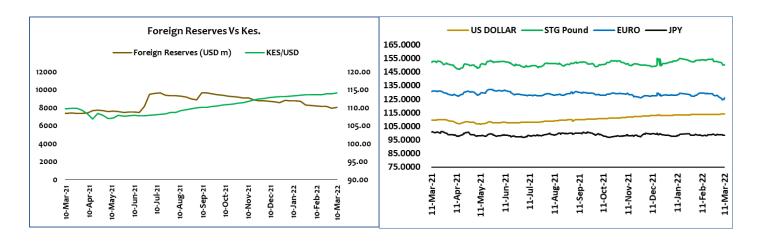


Currency

- The Kenyan shilling weakened 0.2% against the U.S. dollar rising above the KES 114 mark to close the week at KES 114.18 from KES 113.91 the week before. Against the Pound, Euro, and the yen the shilling stood stronger at gains of 1.3%, 0.5% and 0.4% to KES 150.41, KES 126.10, and KES 98.46 respectively.
- During the week, the country's foreign reserves gathered USD. 98Mn from USD. 7,913Mn to USD. 8,011Mn.
- Elsewhere, the dollar index moved 0.5% up w/w making the dollar stronger against several major currencies bolstered by a safe-haven demand in the commodities market.
- In the coming week, the Fed is expected to rule on its interest rate hike signaled by the rising inflation currently at 7.9% against 2.0% target. In England, the Bank of England (BOE) is also expected to hike its rates for a third time since December 2021 amid the rising inflation which hit a 30-year high of 5.5% in January.
