### Daily Market Wrap 11<sup>th</sup> October 2023

#### **Daily Market Performance Summary**

- The stock market prices further fell on Wednesday, October 11, 2023, at a decline of 0.6% overall from the last trading day. Prices on the top 10 most liquid counters at the NSE market had another beating shedding an additional 12.33 points to record a new low of 933.10points since inception on 1st September 2023. NSE 20 was down 0.6% while NSE 25 index fell 0.9% from the last trading day, Monday, 9th October 2023.
- Volumes traded however improved 41.5% to 9.14Mn on increased activities in Safaricom on a further heavy foreign exit. The Telcom giant, Safaricom, saw foreign sales of 98.6% as foreign buys on the counter fell to 0.3% as locals took positions at 99.7% of all the buy side.
- On overall, foreign participation improved to 48.5% supported by heavy foreign sales on Safaricon, East African Brewewries and Equity Group a net foreign outflows of KES 75.19Mn. See below the price movement and foreign performance per stock.

We attribute the heavy foreign outrflows to a weak Kenyan shilling that hit a new low of KES 148.88 per US dollar, CBK rate. We advise our Clients to continue taking positions, especially in the banking stoocks, taking advantage of the low prices.
