# Daily Market Wrap 13<sup>Th</sup> December 2023

#### **Daily Market Performance Summary**

- Stock prices dipped on Wednesday, December 13, 2023, defying gains made in the last trading day on what we view as absorption of the Central Bank Rate review from 10.5% to 12.5%. This is as borrowing rates soar higher in the market with return on investment in government papers becoming lucrative. All market indices experienced a decline an average of 0.6% in the day.
- Volumes traded jumped 380.2% to 17.24Mn pushing the value traded 592.7% up to KES 260.80Mn.
- Safaricom remained the most traded counter with 14.88Mn shares valued at KES 215.01Mn representing 86.3% and 82.4% of the market transactions and value respectively. Safaricom sustained heavy foreign exits as many foreign investors shunned the counter with the day recording only 1.9% foreign buys and 63.9% foreign sales.
- The local currency seems to be reaping off from the above monetary policy, shedding only 0.004% from the last trading day in relation to an average daily value loss of 0.09% witnessed in the eleven months ending 30th November 2023.
