Daily Market Wrap 19th December 2023

Daily Market Performance Summary

- Equities further under performed on Tuesday, 19th December 2023, with prices shrinking by 1.3% on average from that of Monday, 18th December 2023. A total of 14.75Mn shares were transacted valued at KES 222.31Mn with Safaricom moving 78.1% and 70.0% of the market volumes and value traded.
- Market foreign activity further improved to 87.5% with foreign sales overweighing foreign buys at 88.4% as foreign buys stood at 78.4%. Heavy foreign activity remained on Safaricom at an average of 96.2% as the foreign buy and sale sides nearly offset each other.
- Pressure remained on the Kenyan shilling resulting to 0.25% decline from KES 153.78 to KES 154.16 per US dollar on what we view as heavy dollar demand to settle oil imports.
