Daily Market Performance Summary

- Equities market experienced a mixed reaction on 21st December 21, 2023, even as prices gained marginally at 0.1% heavily supported by mid cap counters which were up 1.4% as evidenced by the NSE 25 index.
- Market capitalization remained low at KES 1,413.18Bn in relation to KES 1,411.94 of 20th Dec 2023 and KES 1,999.79Bn of 20th Dec 2022. On 21st Dec 2021 and 21st Dec 2020, the market capitalization stood at KES 2,555.93Bn and KES 2,266.05Bn respectively.
- Value loss on the local currency accelerated 0.19% on 21st Dec 2023 from KES 154.39 to KES 154.69 per US dollar on heavy dollar demand towards oil import settlement, Eurobond coupon payments and the and other expenditures of the festive season.
