#### **Daily Market Performance Summary**

- Equities market prices were slightly up on Monday, 8<sup>th</sup> January 2024 even as the volumes remained low with only 3.56mn shares being exchanged. All market indices were up, led by the all-share index at 0.8%.
- Foreign activity fell by half from 81.5% on Friday, January 5, 2024, to 43.6% on Monday, 8<sup>th</sup> January with a net foreign outflow of KES 5.13Mn from an inflow of KES 10.74Mn last Friday.
- The forex market witnessed a slowdown in the Kenyan shilling depreciation against the US dollar from a loss of 0.2% on Friday to 0.04% from KES 157.32 to KES 157.39 per US dollar.
- Secondary bonds market activity remained low with a slight improvement in value traded from KES 209.70Mn to KES 908.50Mn on an impact from the ongoing primary auction of Wednesday, 10<sup>th</sup> January 2023 for FXD1/2023/03 and FXD1/2023/05 papers. Find our pre-auction note Here for more...
