#### **Daily Market Performance Summary**

- NSE market remain low in the third week of 2024, with 16<sup>th</sup> January 2024(Tuesday) recording only 7.28Mn shares of KES 18.27Mn. The overall market prices were 0.3% from those of Monday, 15<sup>th</sup> Jan 2024. All share index shed 0.3% as NSE 20 and NSE 25 were 0.2% and 0.1% respectively while N10 index gaining marginally at 0.1%
- The telco giant, Safaricom, KCB, Equity and Co-op Bank were the day's top movers in that order, transacting 86.1% of the market value. We retain our buy recommendations, especially on these counters with the exclusion of Safaricom, which has a long-term view in terms of price recovery.
- Secondary bonds market activity declined on Tuesday, 16th Jan. 2023, transacting only KES 1.47Bn from KES 2.86Bn traded on Monday, 15th January 2024. We attribute the decline in value traded to tap-sale issue FXD1/2024/003 and FXD1/2023/005 released on Tuesday, 16th January 2024, with the government targeting KES 15 billion.
