## Daily Market Wrap 28<sup>th</sup> December 2023

#### **Daily Market Performance Summary**

- Year-end book closures elevated equities market prices for a sixth consecutive trading day, as fund managers manage their books for reporting purposes. The Nairobi All-Share index was up 0.5% to 91.68 points on 28<sup>th</sup> December 2023. NSE 20, NSE25 and N10 indices were up 0.8%, 0.4% and 0.3% respectively.
- Market foreign activity declined from 90.9% to 77.8% pulling down net foreign from KES 4.11Mn to KES 2.71Mn on Thursday, 28<sup>th</sup> December 2023. Foreign activity concentrated on Safaricom, KCB and Equity Group in that order, see pricelist on page 2.
- The local shilling lost 0.4% or 0.62 Kenyan cents against the US dollar from KES 155.47 to KES 156.09 per dollar. This represents the highest single day witnessed since June 2021.
