

### Daily Market Performance Summary

- Daily equities market performance remained low on Thursday, January 25, 2024, with investors exchanging only 6.15Mn shares valued at KES 102.31Mn, a slight decline from those of Wednesday, 24th Jan 2024.
- Market indices remained down with a general marginal gain in relation to those of the day before. The Nairobi all share index was up 0.1% supported by a 0.4% rise in the listed mid-cap counters.
- The Kenya shilling lost 0.4% from KES 160.19 to KES 160.80 per US dollar after recording some positive signs in the first three days of the week.
- The secondary bonds market still performed better on 25<sup>th</sup> Jan 2024, trading exchanging KES 4.18Bn from KES 4.94Bn exchanged in mid-week. This is despite the government announcing an amortized new infrastructure bond, IFB01/2023/8.5-years for February 2024, targeting KES 50 billion from the market. Watch out for our pre-auction note.
