Daily Market Wrap 8th February 2023

Daily Market Performance Summary

- Equities market performance was still down on Thursday, February 8, 2024, with only 4.94Mn shares being exchanged valued at KES 81.57Mn, an almost flat activity and value when compared to that transacted on Wednesday.
- The new N10 index lost a further 2.60 points to close the day at 925.48 points, shedding a total of 74.52 points since inception on 1st September 2023. The rest of the indices gained marginally at an average of 0.1%.
- The secondary bonds market remained active despite the ongoing primary auction for IUFB1/2024/8.5 paper whose auction is due next Wednesday, February 14th. Secondary market value exchanged spiked 10.1% from KES3.50Bn to KES 3.85Bn.
- Elsewhere, Kenya opened a Eurobond buyback offer for the Jun-2024 paper for investors who cannot hold the paper until maturity. As a result, yield rates on the paper fell from 15.59% to 9.96% even as the US dollar forex rate remained stable for now three weeks.
