## **Daily Market Performance Summary**

- The equities market turned positive on Thursday, February 15, 2024, gaining marginally in prices at 0.1% being supported by price gains in the banking sector. NSE 20, which was up 0.4% as the new N10 index edged up 0.1%.
- Foreign activity in the stocks doubled from 31.4% to 73.1% supported by heavy foreign sales of 84.1% in relation to a foreign buy of 62.2%, resulting in a 117.7% uptick in net foreign onflows to KES 58.68Mn.
- Value traded in the secondary bonds market jumped 155.7% to KES 6.43Bn on higher tickets of 55 deals in comparison to KES 2.51Bn of 66 deals traded the last trading day.
- The primary market for IFB1/2024/8.5-year saw KES 288.66Bn being subscribed with government accepting KES 240.96Bn representing a 322.4% performance. The paper's coupon was priced at a coupon of 18.4607%. the paper will trade in the secondary market as from tomorrow, Friday, 16<sup>th</sup> February 2024.
- Kenyan shilling continued performing well strongly supported by a weakening demand for the US dollar overweighed by supply side. This is further supported by the recent CBK measures a further rate hike, streamlining of the forex interbank market, removal of a twenty-cent maximum on indicative interest rate hike and adoption of one published rate based on previous day transactions.
