Daily Market Performance Summary

- The NSE equities activity was down on Monday, March 4, 2024, even as prices edged up marginally at 0.1%. Price gains in the banking sector continued to push NSE 20 and the N10 indices 0.6% and 0.3% respectively as the NSE 25 gained 0.1%. Market foreign participation fell to 38.1% from an average of 51.3% on the last trading day.
- Only 4.17Mn shares of KES 79.45Mn exchanged in the day, becoming one of the lowest values witnessed in a single day. Safaricom emerged the market mover transacting 2.20% of KES 29.64Mn out of which 89.2% were foreign exits. The counter witnessed the lowest foreign buys in a single day of 2.6%.
- Secondary bonds activity remains active rising to pushing the value traded 26.9% from KES 7.23Bn to KES 9.18Bn elevated by heavy activities on the new IFB1/2024/8.5-year paper. The paper transacted a total of KES 5.87Bn representing 64.9% of the market value as its value further improved to a yield to maturity of 17.4267% from a coupon of 18.4607%.
