Daily Market Performance Summary

- Kenyan stock market prices were up 1.8% on Friday, 15th March 2024, as the Nairobi All Share Index (NASI) gained 1.8% to stay above the 100-point mark for the second day, a level last seen in mid-August 2023.
- The market remained rallied by the banking sector which so far has recorded stellar growths from the two listed banks, Stanbic and StanChart, which reported 21.8% and 31.8% rises in their dividend per share for full year 2024 which moved from KES 12.60 to KES 15.35 and from KES 22.00 to KES 29.00 per share respectively. A better outlook for the remaining banks continues to push the prices higher. Absa Bank Kenya will release their financials on Monday, 18th March 2024.
- Listed Banks moved the market after trading a total of KES 101.89Mn from 5.46Mn shares traded in the day. KCB Group (KES 24.00 per share, 4.1% up), Equity (KES 42.60 per share, 2.4% up) and Co-op Bank Group (KES 14.05 per share, 3.7%) up were the most traded banking stocks during the day.
- Co-op Bank touched above the KES 14.00 mark to close the day at KES 14.05 per share, a highest price last recorded on 12th March 2020, before the covid-19 pandemic in the country.
- Safaricom closed the week at KES 15.20 on Friday from KES 150.00 the day before on what we view as effect from the KES 0.55 per share dividend book closure which happened on 15th March 2024. Payment date is set for 31st March 2024.
- The Kenyan shilling continued to flourish against some major currencies. Against the US dollar the shilling further re-gained a further 1.7% to trade at KES 135.15 per US dollar on what we view as heavy supply of the dollars in the market after the demand side was weakened by a buyback of the USD 1.5Bn by issuance of a new Eurobond in February 2024.
