### **Daily Market Performance Summary**

- Equities prices were up 0.8% on Tuesday, March 19, 2024, supported by reporting season of banks, insurance among others especially for the full year 2023 and half year ending 2023 (for government listed companies). The banking sector prices were up 1.1% on average led by HFCK, Stanbic and DTBK with price gains of 7.3% from KES 4.11 to KES 4.41, from KES 119.50 to KES 124.25 and from KES 49.30 to KES 51.00 respectively. Equity Group and KCB Group prices grew marginally at 0.8% to KES 43.30 and KES 24.30 respectively, as that of Co-op Bank Group remained stable at KES 14.00 per share.
- Overall market capitalization improved 0.8% to KES 1,579.08Bn. Year to date market capitalization has grown 9.9% supported by better earning results witnessed in the market.
- Market foreign participation declined from 73.0% to 69.6% with net foreign outflows accelerating at 594.0% to KES 77.10Mn, still on heavy foreign outflows.
- The value traded in the bonds market fell from KES 7.54Bn to KES 2.35Bn on what we view as the effect of the primary auction due tomorrow for FXD1/2023/05-year and FXD1/2024/10-year papers.
