### Daily Market Wrap 26<sup>th</sup> March 2024

#### **Daily Market Performance Summary**

- Stock market prices continued an uptrend on Tuesday, March 26, 2024, mainly supported by the ongoing earning season especially in the Banking sector. Locals dominated the market on what we view to be mainly fund managers taking positions to manage their books for Q1-2024. This is as foreign activity fell to 23.1% from 67.5% of all the market activity on Monday.
- The Nairobi All Share Index went up 5.5% signaling a further general rise in the market prices. Month to date and year to date, equities prices have gone up 25.7% and 27.5% respectively. The N10 index gained 5.3% as the NSE 20 3.3%.
- KCB Group was the day's top mover of the day with a turnover of KES 180.18Mn as its prices accelerated up to emerge the day's top gainer at 9.6% from KES 27.20 to close the day at KES 29.80. Safaricom took the second position in both the market value traded and price after exchanging KES 102.28Mn at an average price of 19.25 per share, a 9.4% rise from KES 17.60 of Monday, 25<sup>th</sup> March 2024.
- The secondary bonds market remained active transacting a total of KES 5.59Bn with great focus remaining on the IFB1/2024/8.5 paper as investors take advantage of its better returns.
