Daily Market Performance Summary

- The stock market was down 0.3% in mid-week, 17th April 2024 compared to that of the day before. The all-share index lost 0.3% followed by a 0.2% loss on NSE 25 while the NSE 20went up 0.7%.
- Sector wise, the insurance sector lost the most in the day shedding 2.7% by losses in Sanlam at 9.6% from KES 6.88 to KES 6.22 per share followed by 3.4% and 3.1% losses on Kenya Re and Liberty insurances. CIC Group remained stable with a margin gain of 0.2% ahead of the much-awaited financials for FY 2023. The banking sector prices turned up 1.1% supported by gains on Bank of Kigali (BKG) and HFCK which went up 9.0% and 8.8% respectively.
- Overall, volumes traded however, went up 117.0% to 13.31Mn share, pushing the value traded 202.0% up to KES 435.99Mn. Heavy activities were witnessed on Safaricom as its price fell further from KES 16.95 to KES 16.75 per share on a continued heavy foreign outflow. The counter transacted 10.62Mn shares of KES 177.84Mn, representing 61.3% and 40.8% of the market transactions and value respectively.
