- Safaricom, emerged the day's top mover transacting KES 30.38Mn from1.90Mn shares a head of its full year 2024 results scheduled for 9th May 24.
- The local currency remained stable attracting 0.1% from KES 133.28 to KES 133.20 per US dollar.
