Daily Market Performance Summary

- The stock market prices further gained for the second consecutive trading day on Wednesday, May 8, 2024, going up at 1.1% on average. NASI index and N10 index gained 1.1% each as NSE 20 and NSE 25 further gained 0.8% and 0.9% in the day. As a result, the market cap rose 1.1% to KES 1,642.23Bn.
- Three of our focus stocks, Safaricom, Stanbic and KCB were the most traded stocks in the day. Safaricom exchanged hands 7.64Mn shares valued at KES 78.40Mn ahead of its FY 2024 financials scheduled tomorrow, 9th May 2024 morning. As a result, the Telco giant's price regained back 1.9% from KES 15.65 to KES 16.95 per share.
- Stanbic came second after transacting KES 43.00Mn from 9,100 shares as its price gained 0.4% from KES 124.00 to KES 125.00 ahead of its KES 14.20 final dividend book closure set for 17th May 2024. KCB Group (KES 30.05, -0.2), Equity Group (KES 42.00, -0.2%) and Co-op Bank Group (KES 12.05, +0.4%) and Diamond Trust Bank (DTB) remain our key focus stocks to watch for investment. DTB's KES 6.00 final dividend book closure is set for 24th May 2024.
- The local currency remained strong in the day, recording a 0.5% gain against the US dollar from KES 133.04 to KES 132.40 per US dollar on what we view to be a weak demand for the greenback.
