### Daily Market Wrap 19<sup>th</sup> June 2024

### **Daily Market Performance Summary**

- Stock market activity further improved on Wednesday, 19 June 2024, supported by improved local activity even as average foreign participation dipped from 29.5% to 14.0% with a jump in net foreign outflows from that of KES 6.66Mn to KES 102.36Mn. Volumes traded surged 116.5% from 9.71Mn to KES 21.02Mn shares pushing the value traded 173.1% up to KES 465.74Mn.
- The NSE market prices reversed upwards at a 0.3% gain supported by price gains in the commercials and the telecommunications sectors which recorded growths of 1.4% and 1.1%, respectively. The insurance sector took third position with an average gain of 0.8% supported by Liberty Insurance which emerged the day's top gainer at 9.8% from KES 5.32 to KES 5.84 per share.
- The Banking sector was the day's market mover transacting KES 353.74Mn from 12.47Mn shares. Activity focused on Equity Group and Absa Bank Kenya which moved turnovers of KES 148.99Mn and KES 103.45Mn at average prices of KES 43.50 and KES 14.00 per share to occupy the first and second top market mover positions, respectively.
- In the primary bonds market, the government issued a tap sale of four papers, FXD1/2023/02, FXD1/2024/03, FXD1/2023/05 and FXD1/2023/10 of coupons 16.9723%, 18.3854%, 16.844% and 14.1510% respectively targeting KES 20 billion for budgetary support. The auction is on a first-come-first served basis and is scheduled to close on of before Tuesday, 25th June 2024.
