## KINGDOM SECURITIES

#### **Daily Market Wrap**

- Equities prices were relatively stable on Tuesday, 9 July 2024, even as market activity shrunk by almost half. NASI and NSE 25 indices stabilized at 109.98 and 2,890.38 points respectively as NSE 10 and NSE 20 gained marginally at 0.1% each to 1,131.88 and 1,676.04 points. This was as foreign activity in the market fell from 45.9% to 38.8%.
- Volumes traded dipped 38.8% from 11.08Mn to 6.78Mn shares pulling the value transacted 21.2% down to KES 133.74Mn with heavy activities happening in the banking sector which controlled the market at 56.7% of the value traded.
- Safaricom retained the market mover position after trading 2.4Mn shares of KES 41.48Mn with an average foreign activity of 33.4%.
- The secondary bonds market remained active transacting KES 11.16Bn, over 10 billion for the second day on what we view as heavy foreign outflows following a negative economic outlook on Kenya's economy as rated by the Moody's, a US based credit rating agency. The credit rating agency downgraded Kenya's credit level from B3 to a junk Caa1 level following withdrawal of finance bill.
