### **Daily Market Wrap**

- NSE quoted stocks further lost 0.8% in average on Monday, 22 July 2024, on what continued to be effects of the anti-government protests by the young generation commonly referred to as Gen Z. NSE 10 and NSE 20 lost 0.6% each as NSE 25 shed 0.5% compared to the prices of last Friday, 19 July 2024.
- Value traded sunk 33.7% from KES 208.14Mn to KES 137.95Mn despite a 23.9% rise in the volumes traded from 7.91MN TO 9.80Mn shares. This was as focus most of the traded happened on low priced counters.
- Foreign activity jumped from an average of 9.0% to 55.1% with a net foreign outflow of KES 12.17Mn.
- Safaricom continued experiencing heavy foreign outflows while emerging the day's top with KES 89.78Mn value from 5.54Mn shares. The counter's price further lost 1.2% from KES 16.40 to KES 16.20 per share.
