Daily Market Wrap

- NSE stock prices maintained a downward trend shedding 1.0% as measured by the Nairobi-All Share Index.
 NSE 25 lost 0.6% followed by NSE 10 and NSE 20 With losses of 0.5% and 0.3% respectfully.
- Volumes traded jumped 139.2% up from 11.61Mn to 27.77Mn pushing the value traded 235.5% up to KES 479.89Mn.
- Focus remained on Safaricom which exchanged 21.30Mn shares of KES 331.27Mn. The telco's activities were influenced by a high foreign sale which stood at 60.8% compared to foreign buys of 28.6% on fears of the anti-government protests that have seen its price drop in the last one month. Safaricom's price further shed 2.5% from KES 15.95 to KES 15.55 despite the view of the protests cooling down after the perceived coalition government.
- Banks took second position with a total market turnover of KES 119.31Mn of 4.21Mn shares. The sector was led by heavy activities in Equity Group, KCB Group and Co-op Bank Group which recorded market turnovers of KES 72.57Mn, KES 22.67Mn and KES 20.38Mn in that order. KCB Group lost 2.0% from KES 32.75 to KES 31.50 followed by Equity Group at a 0.1% loss from KES 41.50 to KES 41.45 as Co-op Bank Group stabilized at KES 12.80 per share.
