Daily Market Wrap

- NSE market stock prices remained relatively stable with a minimal downward movement of 0.1%. NSE 25 counters were flat at 2,800.9 points as NSE 20 and NSE 10 lost 0.3% and 0.4% respectfully. Market Foreign activity improved from 55.1% of Wednesday to close Thursday at an average of 81.9.
- Safaricom and BAT were the most traded counters to emerge the top two market movers in that order. This
 was at heavy foreign outflows remained on Safaricom while foreign book transfers appeared to support BAT
 plc. The two stocks controlled the market at 88.7% and 81.4% of the market traded value and volumes traded.
- Safaricom remained the most traded counter transacting 28.43Mn shares of KES 412.19Mn, representing 79.2% and 53.2% of the market volumes and value traded, respectfully
- Banking stocks' prices were up 0.1% even as activity dropped by over a quarter from 2.94Mn to 3.93Mn shares.
 I&M price decline slowed down to a 5.0% decline from KES 22.95 to KES 20.95 per share.
