Daily Market Wrap

- Equities prices declined marginally on the last trading day of September 2023, with only 3.93Mn shares being transacted values at KES 76.35Mn. NASI, NSE 25 and NSE 20 all lost 0.1% each as NSE 10 stabilized at 1,124.72Mn. Market volumes transacted fell drastically from 9.16Mn to 3.93Mn shares, pulling the value traded down 59.9% down to KES 76.35Mn.
- Banks still rallied the market, trading 1.10Mnshares of KES 37.27Mn representing 48.8% of the market value traded. KCB Group emerged the day's top mover with KES 24.01Mn from 0.69Mn shares as its price lost 0.9% from KES 35.00 to KES 44.70 per share. Equity Group gained 0.9% from KES 43.45 to KES 43.85 per share.
- Portland Cement's price further rose 9.9% on the first day of its third consecutive week of gains. The cement manufacturer's price rose from KES 28.80 on 27th September to KES 31.65 9 per share on 30th September, on its anticipated special dividend expected in FY-2024 financials despite recording a loss of KES 720.79Mn in H1-2024. The much-awaited special dividend is signaled to come from the sale of idle assets as part of ongoing reforms geared to clear its debts and increase cement production, as per the statement issued by its management on 12th September 2024. Further, its plant refurbishment seem to be bearing fruits with August 2024 cement production estimated at 50,000 tonnes against a target of 83,000 tonnes according to management plan.
