#### **Daily Market Wrap**

- Equities prices thinned for the second trading day on Thursday, November 7, 2024, shedding 1.1% on overall to negatively impact the market capitalization downwards from KES 1,825.27Bn to KES 1,805.47Bn. NSE 10 lost 0.3% followed by NSE 25 at a 0.2% loss as the NSE 20 rose marginally at 0.1%.
- Volumes traded jumped up 152.1% from 11.15Mn to 28.11Mn shares to push the value traded 103.8% up from KES 146.51Mn to KES 298.61Mn.
- Safaricom emerged as the day's top market mover with KES 164.50Mn value from 10.48Mn shares on rise in its market activities on heavy foreign sales after reporting lower-than-expected financial results for H1-2024. Safaricom's H1-2024 profits before tax fell 27.9% year on year from KES 46.94Bn in H1-2024 to KES 33.86Bn in H1-2024 on heavy losses from Safaricom Ethiopia's currency devaluations. The telco's net profit dropped 63.2% from KES 27.19Bn to KES 10.01Bn in H1-2024 eroded by a higher effective tax rate, watch for full report due tomorrow.
- Following the above profit decline, Safaricom's price fell 4.0% from KES 16.35 to KES 15.70 per share on heavy foreign sales of 80.0% of all its sales compared to its foreign buys of 10.6%. We expect the telco's price to be impacted negatively after the low performance which will impact overall price valuations.
