### Daily Market Wrap 13<sup>th</sup> November 2024

#### **Daily Market Wrap**

- Equities prices were up 0.4% on general price gain across all the listed categories. NSE 10 and NSE 25 were up 0.5% each as NSE 20 and NASI gained 0.4% each.
- Volumes traded however, dipped 43.9% from 22.7Mn to 12.83Mn shares mainly on low activities across the counters. Value traded however climbed 46.7% from KES 139.42Mn to 204.51Mn mainly supported by high value trades that happened in the day.
- EABL emerged as the day's top mover with KES 75.52Mn from only 391,300 shares as its price stabilized at a high of KES 193.00 per share. Safaricom fell to second position with KES 45.75Mn of 2.99Mn shares asits price also stabilized at KES 15.30 per share.
- Banking prices gained 0.6% on average after trading only 1.77Mn shares of KES 67.04Mn led by KCB Group with KES 41.44Mn from 1.05Mn shares. KCB Group price maintained an uptrend with a marginal gain of 0.1% to KES 39.40 per share. Equity Group also maintained an uphill trend at 1.3% gain from KES 48.80 to KES 49.45 per share. The surge in banking prices follows the anticipated high returns come next year when they report their FY-2024 financials.
