Daily Market Wrap 14th November 2024

Daily Market Wrap

- Stock price relaxed down 0.2% on Thursday, November 14, 2024, led by the topmost liquid counters, NSE 10 at a 0.5% value loss. NSE 20 lost 0.3% and NSE 25 and NASI lost 0.3% each.
- Heavy activity on low prices counters saw the market value dip 20.9% from KES 204.51 to KES 161.083Mn despite a rise in the volumes traded. Volumes traded however, rose 15.0% from 12.83MN to 14.75Mn shares rallied by heavy trades low priced counter.
- Safaricom emerged as the day top mover with only KES 66.12Mn from 3.02Mn shares. This was as the heavy activity on EABL fell to only 1000 shares to cause the counters' price shrink 5.8% from KES 193.00 to KES 181.75 per share to appear on the day's top losers list.
- Banking prices further lost 0.6% on average after trading only 2.89Mn shares of KES 93.83Mn still led by KCB Group which took the second market mover position with KES 45.64Mn from 1.15Mn shares. KCB Group and Equity Group maintained an uptrend, gaining 0.4% and 1.1% to KES 39.55 and to KES 50.00 per share respectively.
- Co-op Bank gained a further 1.0% from KES 14.50 to KES 14.65 per share immediately after reporting an 8.5% jump in profits before tax from KES 24.69Bn in Q3-2023 to KES 36.79Bn in Q3-2024, supported by strong growths on its interest incomes. The counter traded 88,400 shares on KES 1.30Mn.
