Daily Market Wrap

- Stock market prices edged up 1.0% at the start of the third week of October as all the price tracking indices went up. NSE 20 stocks gained the most at 1.2%, NSE 25 at 1.0% and NSE 10 at 0.7%. We view the price surge as supported by the Central Bank Rate reduction whose transmission is ongoing in the market
- Volumes traded however dipped 79.2% from 29.65 Mn to 6.18Mn shares pulling the value traded 79.9% to from KES 339.18Mn to KES 68.30Mn
- The banking sector rallied the market to produce the first two top movers, Equity Group and KCB Group, in that order. Equity Group transacted KES 15.63Mn from 337,300 shares as its price dipped 2.0% from KES47.30 to KES 46.35 per share.
