Daily Market Wrap

- Stock prices were up 1.4% on Wednesday, October 16, 2024, pushing all the market tracking indicators up. NSE 25 stocks gained faster at 1.9%, followed by NSE 10 and NSE 20 with gain of 1.4% and 0.9% respectively.
- The volumes traded however remained low at 5.54MN shares valued at KES 126.93Mn but higher compared to 3.63Mn shares of KES 110.49Mn shares traded the day before.
- Banks were top mover for the second trading day, to take the first four market mover positions. KCB Group still emerged the top mover with KES 7.35Mn from 201,300 shares while its price stabilized at KES 36.50 per share for the second consecutive day. Equity Group followed with KES 6.08Mn turnover from 130,200 shares while its price rose 0.8% from KES 46.35 to KES 46.70 per share.
- I&M Group took the third top mover position with KES 6.08Mn from 181,100 shares immediately after announcing issuance of 86.50Mn new sharers to East African Growth Holding (EAGH) at a price of KES 48.42 per share for capital expansion. More information on the new ordinary shares' subscriptions will be made available in due course as per the company's cautionary announcement issued today, 16th October 2024. As a result, the counter's share price thinned 2.3% from KES 25.65 to KES 26.05 per share. The new shares issuance will directly dilute the company's earnings per share and dilute its earnings per share while elevating its capital rations and enable business expansion.
