#### **Daily Market Wrap**

- All market tracking indicators rallied up on Wednesday, October 17, 2024, supported by a general rise in market prices. NSE 10 stocks rose faster at 2.2% followed by NSE 25 at 1.8%, NASI at 1.1% and NSE 20 at 1.0%.
- Market activity went up 300.7% to 21.40Mn shares of KES 449.68Mn compared to 5.34Mn shares of KES 126.93Mn exchanged on Tuesday.
- Focus remained in the banking sector which transacted 8.90MN shares of KES 337.85MN representing 41.6% and 75.1% of the market
- KCB Group remained the top mover with KES 295.93Mn from 351,500Mn shares to account for 65.8% of the market value. As a result, KCB Group's price surged 3.9% from KES 36.80 to KES 38.25 per share.
