Daily Market Wrap

- Stock prices further lost 0.6% on Tuesday, November 19, 2024, on a general decline in prices across the market on drops in market demand. All the market tracking indices edged down with NSE 26, NSE 25 and NASI shedding 0.6% followed by NASE 10 with a 0.5% loss.
- Market activity edged down from 27.37Mn to 19.19Mn shares even as the valued traded went up 27.0% from KES 223.01Mn to KES 283.30Mn on heavy volumes on high valued stocks such as in Stan-Chart, Equity Group and KCB Group.
- Foreign activity improved to 67.8% from 31.9% on Monday, 18th November, supported by improved entries on Safaricom which had an average foreign participation of 77.9%.
- Market attention shifted to Safaricom which emerged as the top mover with KES 180.82Mn from 12.14Mn shares. Safaricom's price, however, declined 0.7% from KES 15.00 to KES 14.90 per share.
- Some increased attention was also spotted on Equity Group, KCB Group and Co-op Bank Group on their prospects of better dividends for FY-2024. KCB Group's Q3-2024 financial release is scheduled for tomorrow, Wednesday, 20th November 2024.
