# KINGDOM SECURITIES

### **Daily Market Wrap**

- Equities prices further shed 0.6% on average for the second day consecutive day on Wednesday, November 20, 2024. NSE 10 lost the most at 1.3% followed by NSE 25 at a 1.1% loss as the NSE 20 remained stable.
- The banking sector took the center stage to trade with 4.78Mn shares of KES 188.99Mn followed by the telecommunication sector with KES 3.81Mn shares of KES 56.40Mn.
- Equity Group emerged as the top mover with KES 96.27Mn from 2.05Mn shares after emerging as the day's top foreign destination. The Group witnessed the foreign entries of 68.2% of all its buy transactions while recording zero foreign sales. Despite this, the Bank's price lost the most at 4.0% from KES 48.95 to KES 47.00 per share
- Stan-Chart declared the second interim dividend of KES 8.00 per share after reporting a 64.3% jump on its profits before tax (PBT) from KES 13.68Bn to KES 22.47Bn by end of Q3-2024. The Bank's net profits went up 62.7% year on year I from KES 9.74BN to KES 15.85Bn. This saw its price gain an additional 1.2% from KES 234.00 to KES 236.75 per share. We retain a BUY recommendation on the Bank's share price target of above KES 275.95 per share.
- I&M Group declared KES 1.30 interim dividend after reporting a 24.1% rise in PBT from KES 11.37Bn by end of Q3-2023 to KES 14.11Bn by end of Q3-2024. Its PAT was up 21.3% from KES 8.20Bn in Q3-2023 to close Q3-2024 at KES 9.95Bn. As a result, the counter's price rose 2.5% from KES 28.10 to KE 28.80 per share.
- KCB Group also reported KES 57.43Bn profits before tax for the period ended Q3-2024, a stellar 41.5% jump from that of KES 40.59Bn reported in the same period last year. The top tier 1 Group's profits after tax soared 49.0% up from KES 30.72Bn in Q3-2023 to KES 45.76Bn by end of Q3-2024. We retain our BUY recommendation on the counter's stock with a revised price target of KES 54.82 per share.
