Daily Market Wrap

- The equities market prices maintained an upward rally, gaining 2.4% on overall supported by increased demand on better valuations as rates edge down. NSE 10, NSE 20 and NSE 25 went up 1.7%, 4.2% and 1.6%, respectfully.
- Volumes traded jumped up five times from 9.01Mn to 57.06Mn shares courtesy of KPLC & Kengen which announced stellar results on Tuesday, 29 October for the year ended 30th June 2024.
- KPLC issued a KES 0.70 per share dividend after reporting a profit after tax of KES 30.47Bn from a loss of KES 3.19Bn reported same time last year. The dividend's book closure and payment dates are set for 2nd December 2024 and 31st January 2025, respectfully. As a result, its price surged 49.7% up from KES 3.50 to KES 5.24 per share. We forecast KPLC share price to hit a target price of KES 7.00 by close of books.
- Kengen declared a KES 0.65 dividend per share after reporting a 35.5% rise in profit after tax from KES 5.02Bn to KES 6.80Bn. Its book closure & payment dates will be announced later. Following this declaration, the stock's price accelerated 31.9% up from KES 3.15 to KES 4.13 per share. Once the book closure is declared, we also issue a target price of KES 6.00 on Kengen supported by this dividend.
- Banking stocks also gained 1.1% on average led by I&M Group at 4.2% from KES 27.30 to KES 28.45 per share on the above expectations.
