Daily Market Wrap 10th December 2024

Daily Market Wrap

- Equities prices further rallied up on Tuesday, December 10, 2024, gaining the most in a single day at 2.8% overall as measured by the Nairobi all share index, NASI. NSE 10 surged 2.5% up followed by NSE 25 with 1.9% gain while NSE 20 rose at 0.8%.
- Market foreign activities jumped up to 59.5%with an improved net foreign inflow of KES 26.98Mn from 35.2% of of KES 18.75Mn net foreign inflows recorded on Monday, 9th December 2024.
- Heavy activities happened on Safaricom which moved KES 556.64Mn from 31.63Mn shares, representing 87.0% and 77.3% of the day's market value and volumes traded respectively. The telco giant's foreign activity improved from 52.2% to 59.8% with foreign buys hittingb62.1% as foreign sales also improved to 57.6%. Attention on Safaricom saw its price rise 6.3% from KES 16.55 to KES 17.60 per share.
- Banks transacted only 1.92Mn shares of KES 66.51Mn led by BK Group which exchanged 1.22Mn shares of KES 42.82Mn after its price climbed 5.3% up from KES 33.25 to KES 35.00 per share.
