#### **Daily Market Wrap**

- The stock market activity closed higher on Wednesday, December 11, 2024, trading 52.11Mn shares of KES 952.20Mn compared to 40.94Mn shares of KES 639.94Mn traded the day before.
- Overall market prices relaxed marginally at 0.7% after a first rise of 2.8% recorded the day before, on Tuesday, December 10, 2024.
- Foreign participation jumped up to 73.6% with an improved net foreign inflow of KES 117.07Mn in relation with an average of 59.5% of KES 26.98Mn net foreign inflows.
- Attention remained on Safaricom which transacted KES 779.80Mn from 45.87Mn shares, accounting for 82.0% and 88.0% of the total market value and volumes exchanged.
- Bonds value traded surged up 36.4% up to KES 9.16Bn from 130 deals compared to KES 6.72Bn of 119deals traded on Tuesday.
