Daily Market Wrap

- Equities prices experienced mixed reactions on Monday, December 16, 2024, with the NSE 10 and NSE25 shedding 0.7% and 0.6% respectively, while NSE 20 gaining 0.4%. Overall, average prices were relatively stable as measured by the Nairobi all share index.
- Market activity dipped by over half from 18.18Mn to 7.66Mn shares, to pull the value traded 53.8% down to KES 122.10Mn.
- Foreign participation jumped up from 34.2% on Friday last week to 58.1% on Monday, December 16, 2024. This saw the net foreign inflows shrink from KES 62.73Mn to KES 11.40Mn.
- The market focus remained on the banking and the telecommunication sectors. Banks moved a total of KES 76.36Mn from 2.00Mn shares while Safaricom exchanged KES 34.03Mn from 1.99Mn shares.
- KCB Group emerged as the day's top mover with KES 45.40Mn from 1.15Mn shares as its price stabilized at KES 39.50 per share.
