# Daily Market Wrap 18th December 2024

## KINGDOM SECURITIES

### **Daily Market Wrap**

- Equities maintained an upward rally on Wednesday, December 18, 2024, going up 0.3% on gains mainly from low capitalization counters. NSE 10, NSE 20 and NSE 25, however, lost at 0.3%, 0.4% and 0.5% respectively.
- Market activity climbed up to 174.60Mn shares of KES 9,381.36Mn courtesy of the Bamburi acquisition transaction which exchanged hands 137.06Mn shares to Amsons Group. This represented a provisional early performance of 48.1% against a total targeted acquisition of 362.96Mn shares.
- Foreign participation almost doubled to 51.5% on Wednesday, December 18, 2024, from an average 29.4% on Tuesday.
- Heavy market transactions were also noted in Safaricom which traded 13.54Mn shares to emerge the day's top mover with KES 238.30Mn. Increased foreign demand on the counter saw its price further up 2.0% from KES 17.25 to 17.60 per share. Its average foreign participation rose to 73.1% with foreign buys being 88.3% of all buy transactions as foreign sales also grew to 57.9% of all the sale side transactions.
- Banking prices were up further up 0.4% on a general price surge across the listed banks as their financial year comes to an end.
