### **Daily Market Wrap**

- Stock prices remained relatively stable on Thursday, November 28, 2024, declining marginally at 0.1% as measured by the Nairobi all share index, NASI. Only NSE 10 gained at 02% as the rest remained flat to those recorded on Wednesday.
- Market foreign activity jumped up from 70.4% to 84.4% still elevated net foreign outflows of KES 189.00Mn from a net foreign outflow of KES 152.10Mn traded yesterday.
- Market activity jumped 114.9% up from 29.73Mn to 63.88Mn shares, pushing the value up 115.3% from KES 472.37Mn to KES 1,017.21Mn.
- Safaricom emerged as the day's top mover with KES 766.72Mn from53.24Mn shares, representing 75.4% and 83.4% of the market value and volumes transacted. This was largely on high foreign book transfers that happened in the giant telco. The counter's foreign buys stood at KES 670.12Mn or 87.4% of all its buys while its foreign sales rose to KES 755.46Mn or 98.5% of all its sale side transactions.
