### **Daily Market Wrap**

- Stocks were up 0.7% on average on Monday, January 6, 2025, still rallied by general price recoveries with notable growths being witnessed in the insurance, telecommunication and the energy sectors with upticks of 3.3%, 1.4% and 1.3% respectively. NSE 20 and NSE 25 stocks gained 0.3% each followed by NSE 10 at 0.1% growth.
- Heavy market activities were witnessed on Safaricom, which emerged as the day's top mover with KES 410.78Mn from 23.34Mn shares as its price edged up 1.4% to KES 17.60 per share.
- Attention also remained in the banking sectors which took positions 2, 3 and 5 in the top five movers' list, led by Equity Group and KCB Group which moved KES 130.13Mn and KES 63.44Mn. Equity Group's price shed 0.4% to KES 47.80 while KCB Group gained 0.2% to KES 42.90 per share.
- Stan-Chart closed the top five movers' list with KES 18.12Mn after hitting a high of KES 300.00 per share, a level last seen in 2015, to average at KES 295.50 per share as of the 6<sup>th</sup> day of January 2025. Overall, banking prices were up 0.2%.
