Daily Market Wrap

- Stocks were up 0.7% on average on Monday, January 6, 2025, still rallied by general price recoveries with notable growths being witnessed in the insurance, telecommunication and the energy sectors with upticks of 3.3%, 1.4% and 1.3% respectively. NSE 20 and NSE 25 stocks gained 0.3% each followed by NSE 10 at 0.1% growth. NSE 20 gained the most at 1.2%, NSE 25 at 0.7% & NSE 10 at 0.2% gain.
- Market focus remained on the banking sector which moved 8.20Mn shares valued at KES 342.53Mn, representing 33.9% & 78.1% of the activity & value respectfully. KCB Group topped the top movers list with KES 184.60Mn from 4.29Mn shares while its price rose marginally at 0.2% to KES 43.00. The counter remains among our top buy recommendations.
- Stan-Chart came second with KES 63.14Mn value from 210,300 shares as its price hit an average 9-year high of KES 300.75 per share. Absa Bank (k) took third position with KES 37.96Mn from 2.05Mn shares. Equity Group closed the top five movers' list with KES 17.67Mn from 386,600 shares as its price rose 0.3% to KES 47.95
- KPLC emerged the day's top Gainer with a 9.9% gain from KES 5.86 to KES 6.44 per share after trading 2.89Mn shares, on what appears to be speculative investing
- Market foreign participation dipped by half from 46.2% to 23.9
