Total Value

- Stock prices remained relatively stable on Thursday, January 9, 2025, compared to those traded on Wednesday. Market activity, however, jumped 27.3% up to trade 37.88Mn shares of KES 421.32Mn, as investors shifts to equities.
- Daily foreign activity further fell for the third consecutive day to 9.8% on average from 17.8% the day before.
- Banks remained the focus of the day to move 10.82Mn shares valued at KES 202.61Mn and emerge the top mover. Overall banking prices dropped by 0.3% with nearly all banks recording a marginal decline or remaining stable.
- Absa Bank (k) emerged top mover with KES 147.07Mn from 7.82Mn shares after its price resisting at a high of KES 18.80 per share. Equity Group took the fourth market mover position with KES 25.68M after trading 539,600 shares at an average price of KES 47.60, like that traded midweek.
- Safaricom came second with KES 115.15Mn from 6.42Mn shares. Its price rose 0.9% from KES 17.80 to KES 17.95 per share.
- Kenya Airways emerged the day's top gainer at 9.7% from KES 5.22 to KES 4.76 in just 4-days after resuming trading on Monday, 6th January 2024. This is after the listed national carrier recording KES 513Mn in its half year ending June 2024 since 2013.
