Daily Market Wrap

- Overall stock market prices were relatively stable on 13th January 2025, as the several stocks resisted an up-trend at the start
 of the third week of 2025. However, NSE 10 stocks lost 0.1% as NSE 20 and NSE 25 also lost 0.5% each as investors cash out
 profits in these respective indices.
- Market activity fell 29.4% to 20.51Mn shares valued at KES 172.61Mn from 29.03Mn shares of KES 607.55Mn traded last Friday
- Market focus remained on the banking sector which traded a total 10.82Mn shares valued at KES 202.61Mn. The sector's overall prices came down 0.3% on average as some prices receded down in some counters after hitting their highs.
- Stan-Chart emerged as the day's top mover with KES. 43.07Mn from 143,700Mn shares, as its price dropped marginally at 0.1% from KES 300.00 to KES 299.75 per share.
- Kenya Airways emerged the day's top gainer at 9.8% from KES 5.74 to KES 6.30 per share while Kenya power lost the most at 9.5% after taking the second mover position with KES 25.94Mn from 4.113Mn shares.
- HF Group further rose 9.7% from KES 5.80 to KES 6.36 per share still on its improved market valuation after a successful rights issue which will see it expand its retail lending business.
