Daily Market Wrap

- Equities prices rose marginally on Tuesday, 14th Jan 2024, at 0.1% even as market activity remained relatively high. A total of 28.81Mn shares were traded valued at 242.89Mn, 40.5% and 40.7% higher compared to 20.51Mn shares of KES 172.61Mn exchanged on Monday
- Banking prices reversed up 0.2% as investors' focus remained on the sector to trade 6.94Mn shares of KES 125.29Mn. The rise in the average price was supported by HF Group's price, which accelerated 8.5% up from KES 6.30 to hit a new high of KES 6.90 per share. This follows HF Group's improved market valuation after a successful rights issue which we expect to support the Group's businesses.
- Safaricom lost 0.5% to KES. 18.10 after trading 2.53Mn shares of KES 45.75Mn as Equity Group gained 1.2% to KES 48.35 after trading only 129,500 shares of KES 6.26Mn.
- Bonds value traded jumped 237.3% up from KES 2.51Bn to KES 8.47Bn despite the ongoing primary auction closing tomorrow, 15th January 2025, for FXD1/2018/15 of 12.65% coupon and FXD1/2022/25 of coupon 14.1885.
