Daily Market Wrap

- Stick prices reversed down 0.2% on average for the first time after weeks of an upward rally to pull all the four indices down. NSE 10 lost the most at 1.2% followed by NSE 25 at 1.0% and NSE 20 at 0.4% loss.
- Volumes traded dropped 16.5% to 24.06Mn shares valued at KES 3007.80Mn.
- Banking prices reversed 0.7% down on average wit pan exception of HF Group which gained an additional 9.0% from KES 6.90 to KES 7.52 per share on its improved market valuation. This is even as we advise our clients to take early profits especially on Standard Chartered and Absa Bank Kenya.
- Absa Bank (k) recorded its first notable losses of 6.8% from KES 18.45 to KES 17.20 per share after weeks of going up to hit a high of KES 19.10 per share on Thursday last week. This saw Absa emerge second on the top losers' list. Co-op Bank Group lost 3.6% from KES 16.45 to KES 15.85 per share after trading 173,800 shares of KES 2.75Mn while Stan-Chart also lost a further 2.2% from KES 295.75 to KES 289.25 after trading 16,700 shares of KES 4.83Mn.
- Safaricom regained back its top mover position with KES 147.57Mn after trading 8.09Mn shares at an average price of KES 18.25 per share, 0.8% higher from KES 18.10 of Tuesday
- Kenya Airways further gained 9.8% from KES 6.92 to KES 7.60 on it eighth trading a day after the trading suspension lift of last week on Monday. The price surge is partly viewed as speculative and improved market valuation following the airline's first profit recorded in over a decade recorded in H1-2024.
