Daily Market Wrap

- NSE stock prices turned up 0.8% on Thursday, January 16, 2025, to recover and surpass the losses made on midweek trading. Major price upticks happened in the telecommunication sector and some several low capitalization counters. As a result, NSE 10 and NSE 25 rose 0.6% and 0.2% respectively while NSE 20 lost 0.7%.
- Market transactions jumped 41.4% up to 34.02MN shares to double the value traded at 129.0% from KES 307.80Mn to KES 704.95Mn elevated by a rise in foreign participation from 15.5% to 68.1%.
- Heavy foreign attention was spotted in EABL, Safaricom, Equity Group and KCB Group with averages of 90.5%, 85.9%, 94.9% and 42.1% respectively. This saw these counters occupy the day's top four market mover positions, see table below.
- The banking sector lost 0.3% for the second consecutive trading day as prices of many banks stabilize down after hitting their highs.
- Kenya airways retained the top gainer position with a daily maximum daily gain of 10.0% from KES 7.60 to KES 8.36 per share on improved market valuation following the airline's first profit recorded in over a decade recorded in H1-2024. The rally also appears to be speculative.
