Daily Market Wrap

- Stock prices further went up 0.2% overall on Tuesday, 21st January 2025 on gains from the medium and low capitalization counters.
- Market activity improved 34.5% from 19.04Mn to 25.11Mn, to double the value traded from KES 210.02Mn to KES 432.18Mn. This was mainly supported by heavy local trade which saw foreign activity drop from 26.8% to 23.7%.
- The banking sector gained a further 0.7%, helped by faster price rises in HF Group and I&M, which were up 5.1% and 2.1% to KES 9.42 and to KES 33.30 per share respectfully. This is even as market attention shifted to Safaricom which moved 12.29Mn shares of KES 233.43Mn to emerge the day's top mover. The giant telco's price gained an additional 0.5% from KES 18.90 to KES 19.00 per share despite its low foreign participation of 27.7%.
- KCB Group and Equity Group gained 1.2% and 0.6% to KES 43.60 and to KES 48.75 per share respectfully. This saw KCB Group take the top second mover position with KES 41.0Mn as Equity Group closed the top fiver movers' list with KES 22.76Mn value.
- The secondary bonds market remained active to trade KES 9.13Bn value from 158 transactions, a 3.7% and 189.7% decline in value and deals traded. This is even as investors rush to take positions ahead of an expected acceleration in the sector's returns as interest rates come down.
